This Security Agreement is mutually agreed upon and entered into between the juristic person, MARIANNE BORCHGREVINK CLAUSSEN© and any and all derivatives, and variations in the spelling of said name except :Marianne-Borchgrevink: Clausсен.©, hereinafter jointly and severally "Debtor", and the living, breathing, flesh-and-blood Woman, known by the distinctive appellation :Marianne-Borchgrevink: Clausсен.©, hereinafter "Secured Party Creditor", on the Twenty-third Day of the Second Month in the Year of our Christ Two Thousand and Twenty-one.

In consideration for Secured Party Creditor:

-A, constituting the source, origin substance, and being, i.e. basis of "pre-existing claim", from which the existence of Debtor is derived, and the basis upon which Debtor functions as a transmitting utility, i.e. serves as a conduit, granting Secured Party Creditor capacity for interacting, contracting, and exchanging goods and services in commerce with other artificial/juristic persons;

-B, constituting the source of Debtor's assets, via the sentient existence, exercise of faculties, and labour of Secured Party Creditor, which provides valuable consideration sufficient for supporting any contract whatsoever that Debtor may execute and concerning which Debtor may be regarded as bound, and;

-C, providing the security for payment of all sums now due and owing, and as might become due and owing, by Debtor, Debtor for valuable consideration, does hereby and herewith Agree and Covenant that Debtor shall undertake the obligation of;

-D, functioning and serving as a transmitting utility for the benefit of the Secured Party Creditor, granting Secured Party Creditor ability engaging in commerce with other juristic persons, and;

-E, indemnifying, defending, and holding Secured Party Creditor harmless from and against any and all liability, claims, demands, orders, summonses, warrants, detainers, judgements, damages, costs, losses, liens, levies, depositions, lawsuits, legal actions, penalties, fines, interest and expenses whatsoever both absolute and contingent, due and as might become due, now existing and hereafter arising, howsoever evidence, suffered, incurred by, and imposed on Debtor, and for whatever reason, purpose, and cause whatsoever. **Debtor, for valuable consideration, does also hereby and herewith expressly acknowledge, consent, and agree that Secured Party Creditor can not and must not, under any circumstance, nor in any manner whatsoever, be deemed an accommodation party, nor a surety, for Debtor.**

Words Defined - Glossary of Terms

As used in this Security Agreement, the following words and terms are as defined in this section, non obstante:

Appellation. In this Security Agreement the term “appellation” means: A general term that introduces and specifies a particular term which may be used in addressing, greeting, calling out for, and making appeals of a particular living, breathing, flesh-and-blood Woman.

Conduit. In this Security Agreement the term “conduit” signifies a means: of the transmitting and distributing energy and the effects/produce of labour, such as goods and services, via the name “**MARIANNE BORCHGREVINK CLAUSSEN©**”, also known by any and all derivatives and variations in the spelling of said name of Debtor except “:Marianne-Borchgrevink: Claussen.©”.

Secured Party Creditor. In this Security Agreement the term “Secured Party Creditor” means: the living sentient Woman known by the distinct appellation :Marianne-Borchgrevink: Claussen.©.

Debtor. In this Security Agreement the term “Debtor” means: **MARIANNE BORCHGREVINK CLAUSSEN©**, also known by any and all derivatives and variations in the spelling of said name except :Marianne-Borchgrevink: Claussen.©.

Derivative. In this Security Agreement the term “Derivative” means: coming from another; taken from something preceding; secondary; that which has not the origin in itself, but obtains existence from something foregoing and of a more primal and fundamental nature; anything derived from another.

Ens Legis. In this Security Agreement the term “Ens Legis” means: a creature of the law; an artificial being – as contrasted with a natural Woman – such as a corporation, considered as deriving its existence entirely from law.

In this Security Agreement the term “**MARIANNE BORCHGREVINK CLAUSSEN©**” means the Trade-Name; **MARIANNE BORCHGREVINK CLAUSSEN©**, and any and all derivatives and variations in the spelling of said name except :Marianne-Borchgrevink: Claussen.©, Copyright©2021 by :Marianne-Borchgrevink: Claussen.©. All Rights Reserved.

Juristic Person. In this Security Agreement the term “juristic person” means: an abstract, legal entity Ens Legis, such as a corporation, created by construct of law and considered as possessing certain legal rights and duties of a human being; an imaginary entity, such as NAME, which, on the basis of legal reasoning, is legally treated as a human being for the purpose of conducting commercial activity for the benefit of a sentient, living being such as :Marianne-Borchgrevink: Claussen.©

Living, breathing, flesh-and-blood Woman. In this Security Agreement the term “living, breathing, flesh-and-blood Woman” means: the Secured Party Creditor, :Marianne-Borchgrevink: Claussen.©, a sentient, living being, as distinguished from an artificial legal construct, Ens Legis, i.e. a juristic person, created by construct of law.

Words Defined - Glossary of Terms

In this Security Agreement, the following words and terms are defined in this section, not otherwise defined herein.

Agreement means the Security Agreement, including all amendments, supplements, and exhibits thereto, and any other documents or instruments which may be used in administering, enforcing, calling out for, and making payment of the obligations hereunder.

Assignor means the party to the Security Agreement who assigns or purports to assign to the Assignee, by operation of law or otherwise, all or part of its right, title, and interest in the assets of the Assignor, whether or not the Assignor is a party to the Security Agreement.

Secured Party means the party to the Security Agreement who is entitled to the benefit of the security interest created by the Security Agreement, whether or not the Secured Party is a party to the Security Agreement.

Debtor means the party to the Security Agreement who is obligated to pay the debt secured by the Security Agreement, whether or not the Debtor is a party to the Security Agreement.

Collateral means all property, whether tangible or intangible, that is in the possession, custody, or control of the Debtor, or that is in the possession, custody, or control of any third party, which is subject to the security interest created by the Security Agreement.

Equity means the interest in the assets of the Debtor, whether or not the equity is subject to the security interest created by the Security Agreement, which is not subject to the security interest created by the Security Agreement.

Maritime-Borghgraven Clause means the clause in the Security Agreement which provides that the Debtor shall not assign, transfer, or otherwise dispose of its interest in the assets of the Debtor, whether or not the assets are subject to the security interest created by the Security Agreement.

Non obstante. In this Security Agreement the term “non obstante” means: words anciently used in public and private instruments with the intent of precluding, in advance, any interpretation other than certain declared objects, purposes.

Security Agreement. In this Security Agreement the term “Security Agreement” means: the written express, Security Agreement No. MBC 230221_SA dated Twenty-third Day of the Second Month in the Year of our Christ Two Thousand and Twenty-one, between Secured Party Creditor and Debtor, together with all modifications of and substitutions for said Security Agreement.

Sentient, living being. In the Security Agreement the term “sentient, living being” means: the Secured Party Creditor, i.e. :Marianne-Borchgrevink: Claussen.©, a living, breathing, flesh-and-blood Woman, as distinguished from an abstract legal construct, such as an artificial entity, juristic person, corporation, partnership, association, and the like.

Signature. In the Security Agreement the term “signature” means: “The act of putting down a man’s name, at the end of an instrument to attest its validity, the name thus written. A “signature” may be written by hand, printed, stamped, typewritten, engraved, photographed, or cut from one instrument and attached to another, and a signature lithographed on an instrument by a party is sufficient for the purpose of signing it; it being immaterial with what kind of instrument a signature is made” Blacks Law Dictionary 4th Edition. See also Uniform Commercial Code 2. Edition; UCC §3-401 (b) (what is considered signature).

Signed. See UCC §1-201 (39) (what is considered signed).

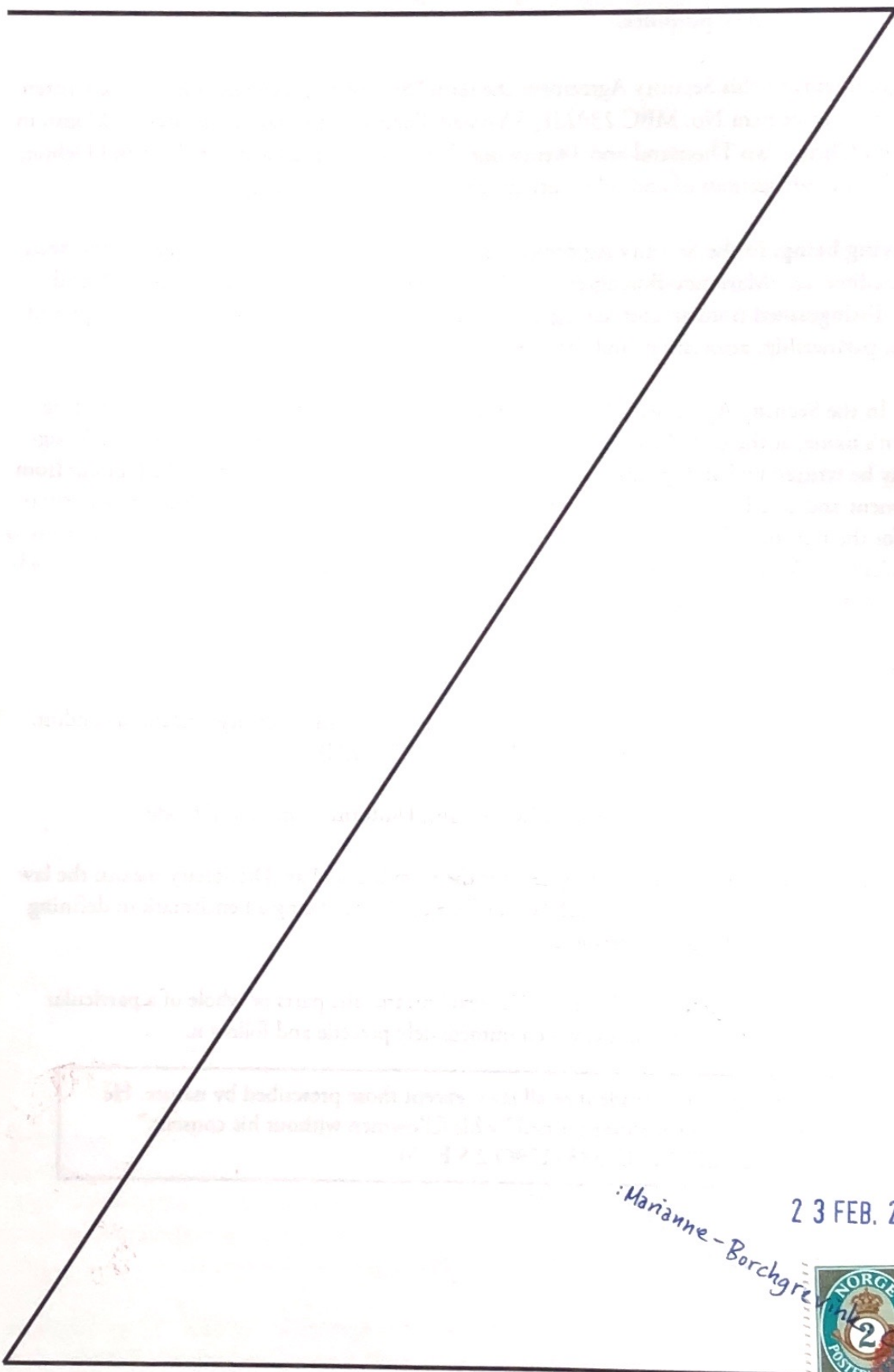

UCC. In this Security Agreement the term “UCC” means: Uniform Commercial Code.

Blacks Law Dictionary. In this Security Agreement the term Blacks Law Dictionary means: the law dictionary published by WEST PUBLISHING CO. The dictionary being a benchmark in defining the meaning of words in a legal and juristic context.

Context. In this Security Agreement the term “Context” means: the parts or whole of a particular contract and comprises those parts of text which immediately precede and follow it.

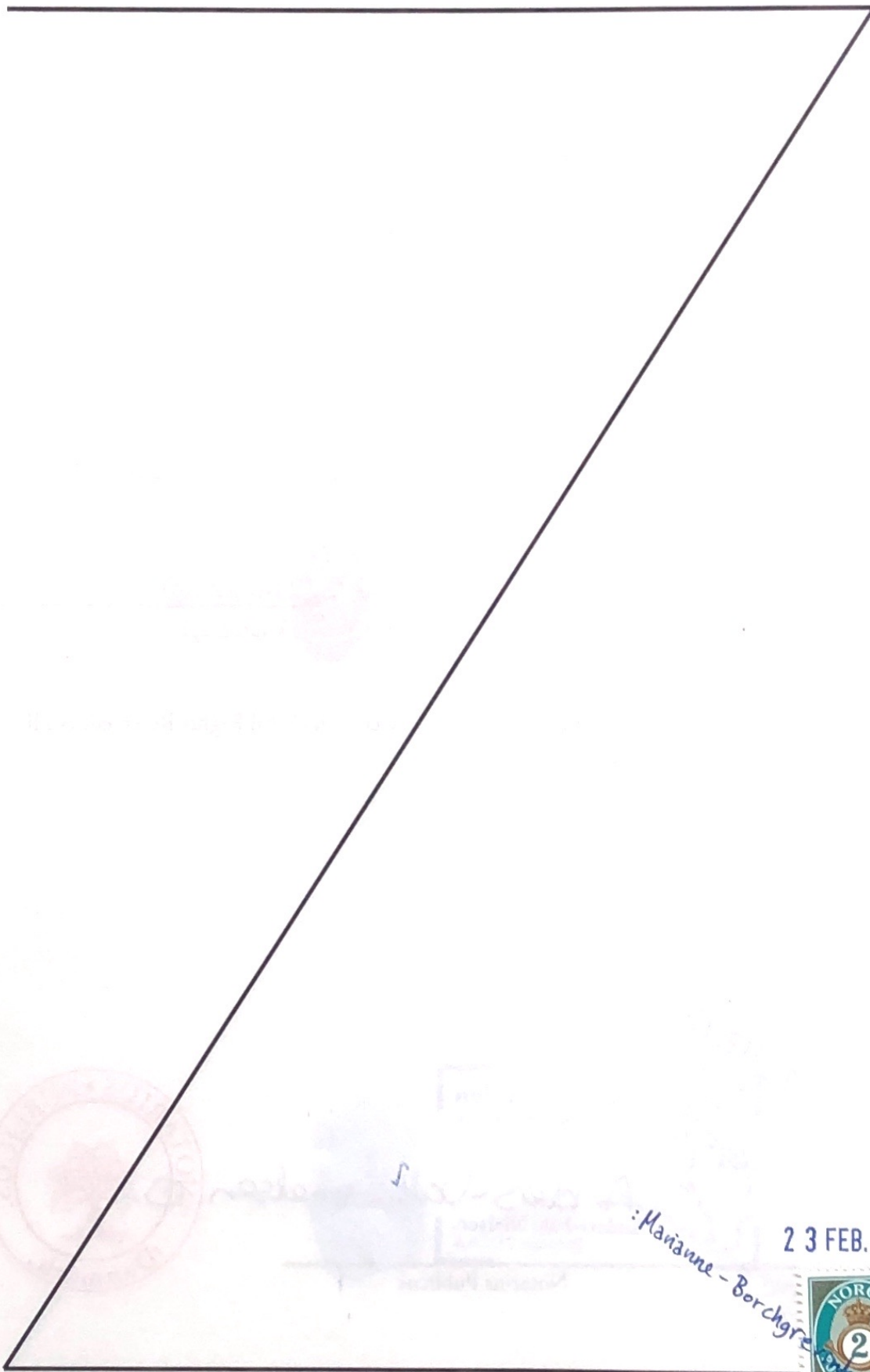
